



# FROM THE DESK OF MATT PIVARNIK


Community Leaders,

# STR'S DESTINATION REPORT/TRAVEL STATS (THRU MARCH)

The CRM project continues to move forward. Final configuration documents began circulating in late April for the Partnership team to sign off on the overall design so that the consultants can begin development of the environment and automations. The last hurdle is to build out the accounting system and the CRM system interfaces. The Partnership team has been working with Sage Intacct to get a project opened and a developer assigned to our case so that the CRM developers. Ideally, the Intacct developers will work together to make the magic happen.

BioKansas, in partnership with GO Topeka and Plug and Play Topeka, will be hosting a golf scramble to celebrate the graduation of the first Plug and Play cohort of startup companies in Topeka on Thursday, June 10. February room demand was down about 18 percent from 2020 - a slight increase from January. As expected, our occupancy rate remained down more than 10 percentage points for the month (38.87%) vs. 2020.

March was a bit more interesting. On March 14, the data began to split as we compare ourselves to the shutdown that occurred last year. For the month, March room demand was up 34 percent from 2020 - by far the best year-over-year increase in a very long time. Our occupancy rate exploded to just over 48% - up 29% from 2020. Interestingly, ADR decreased slightly compared to last year. This was expected as we anticipate a slower recovery for hotel rates relative to demand. ADR for March was an estimated \$74.93 (down from \$78.81 in 2020) placing monthly hotel revenue at an estimated \$3,057,622 (up about 27 percent from 2020).

# TOPEKA YOUTH COMMISSION

The restaurant industry has been among the hardest-hit sectors during the economic downturn caused by the COVID-19 pandemic. To help bring jobs back and revive the industry, the American Rescue Plan, signed into law by President Joe Biden, established the \$28.6 billion Restaurant Revitalization Fund at the U.S. Small Business Administration (SBA). The SBA will administer the funds to the hardest-hit small restaurants. details on application requirements, eligibility, and a program guide are now available in English at www.sba.gov/restaurants or in Spanish at www.sba.gov/restaurantes.

Ahead of the application launch and over the next two weeks, the SBA will establish a sevenday pilot period for the RRF application portal and conduct extensive outreach and training. The pilot period will be used to address technical issues ahead of the public launch. Participants in this pilot will be randomly selected from existing PPP borrowers in priority groups for RRF and will not receive funds until the application portal is open to the public.

# COLLAB EFFORT WITH THA BRINGS NEW BIZ TO UNDERSERVED MARKET

#### METL COALITION

2021 continues to perform in line with expectations. In March, the Partnership was able to provide some compensation adjustments to employees who were negatively affected by COVID in 2020. This was made possible by the PPP funds secured in late January. As a result, March payroll expenses came in over budget resulting in a YTD net loss of 38K.

The PPP funds are currently represented as debt on the books until the proceeds are formally forgiven. At that time, the Partnership will recognize revenue to offset the net loss. Additionally, VTI revenue continues to outperform the conservative 2020 budget.

Minority and Women Business Development (MWBD) and the Topeka Housing Authority (THA) will open the doors to the THA Empowerment Center, a pilot incubator program used to seed and grow small businesses in underserved communities. This project, a collaboration between THA and MWBD, aims to serve as a catalyst for economic prosperity by creating and fostering these businesses. The THA Empowerment Center will open its doors on Friday, May 14 with five business startups. The THA tenants have thoroughly investigated their market. They participated in Fast Trac, worked with a business coach to fortify their business plan. They will continue to receive support through coaching and consultation, programming and financial resources. The METL Coalition (Manhattan, Emporia, Topeka, Lawrence) has been meeting virtually, watching the 2021 legislative session closely and has weighed-in on several important issues. COVID-19 has limited the group's activity calendar considerably but that won't prevent them from reenforcing the METL brand in May. When they return for the veto session in early May, the 28 legislators who represent the METL region will find a gift waiting for them to remind them of the group's appreciation for their public service and reenforcing our various shared priorities.

Tulip Time and the will to travel; brought motor coaches and their guests back to Topeka during April. The Visit Topeka staff worked with five group tour planners to coordinate their itineraries around sightseeing for tulips and add additional activities around the community.

The motor coach/tour market is rebounding fast, and Visit Topeka is looking to capitalize on the surge with a campaign aimed at 500+tour organization in our database. In April, we will target six month and one year planning cycles which will hopefully have more residents seeing those motorcoaches around town soon.

The 2021 Top City Interns program will return for its fifth year on June 1 with a kickoff celebration at Topeka Zoo and Conservation Center. In all, 70 in-person interns and a total of 200 interns will be working throughout the summer. Presently, 18 different Topeka area companies are involved. At the June 1 kickoff event, interns will gather to socialize, learn more about Topeka, and get a behind-the-scenes tour of the Zoo from Director Brendan Wiley. With this and other Top City Intern events occurring throughout the summer, interns will be able to witness Topeka's quality of life while also gaining professional and social experiences.

With spring sports starting, sports sales see the optimism continue. Planners are looking ahead to the fall and next spring for their events. In addition, valuable meetings with groups looking at larger scale future events are starting to happen, which bodes well for our city. Currently, the pipeline has 11 leads with 7,369 room nights and \$5.8 million in economic impact.

Staff booked one event this past month as well as lost a piece of business. The lost business was the 2023 Kansas Shrine Bowl. In 2020, the Kansas Shrine Bowl was able to host their game at Hummer Sports Park during an abbreviated weekend and staff was optimistic about the return. Unfortunately, we will not be able to host in 2023 but will continue to look at this game as an opportunity in the future.

# MITCHELL TO KEYNOTE SMALL BIZ AWARDS

Michael L. Barrera, US Small Business Administration District Director, Kansas City District Office presented to the Small Business Council in April. Barrera is newly appointed to the Kansas City District and has vowed to make the Topeka area a top priority as he strengthens the outreach efforts of the SBA. The Governor and some others had been proposing the new KDHE lab (see "KDHE") be housed inside the Docking State Office Building, a large eyesore on the southwest corner of the Capitol Complex. This held appeal because it would have brought close to 100 professional jobs to downtown and complemented the emerging innovation district. Once it became clear that leadership in the House and Senate had no desire to locate the lab next to the Kansas Statehouse, the fate of the Docking Building become complicated and uncertain. So, the Chamber and DTI decided to simplify, clarify and amplify their shared position on the matter: (i) the State should not rehabilitate unnecessary office space inside Docking and, thus, harm our local developers who have invested to create office space in downtown for State tenants; (ii) the corner of 10th & Harrison needs to be restored in some manner; and (iii) the KDHE lab MUST stay in Topeka. Any solution, from among the many being considered, which satisfies all three of these important priorities will almost certainly win both groups' support.

# BLACK BUSINESS AFTER HOURS RETURN

Visit Topeka staff members have been actively engaged in regional, state and national groups. In the past month, staff has participated in the Northeast Kansas tourism coalition meeting. The focus of the group is tourism promotion in the region and Visit Topeka specifically talked about the upcoming African American Travel Conference. On the state level, staff participated in the board of directors for Travel Industry Association of Kansas (TIAK), which applauded the move of the State Tourism department into the Department of Commerce. SportsKS is another statewide tourism coalition which continues to see the momentum of sports travel and will host their first quarterly in person meeting in May with Jackie Stiles as the guest speaker. TourKS, a statewide coalition which focuses on group travel, is currently working on their new marketing plan and branding as they come out of the pandemic.

In late March, a joint legislative committee published a surprising recommendation that the KDHE laboratory currently located at Forbes Field, and badly in need of a new home, be put out for bid to determine whether any other Kansas community was willing to offer an incentive package to entice the lab out of Topeka. The Chamber and DTI immediately engaged with the entire Shawnee County delegation, the Governor's office and other legislative leaders to make a very aggressive case for keeping the lab in Topeka and not pitting Kansas communities against one another this way. As the legislature returns, there is cautious optimism that, while the matter may be discussed, relatively few in the Statehouse ultimately favor putting the lab anyplace other than the Capital City.

Business networking provides business owners the capacity to collaborate with others and to expand their network. The Black Business After Hours, launched in 2018, set the stage for many new business relationships and opportunities. Due to the pandemic, it had been placed on pause. It served as a platform to provide community insight, ideas, information and introduction of new business trends and connections. The Black Business After Hours will return in May and be held bi-monthly.







#### SHAWNEE COUNTY'S LABOR MARKET

The official labor statistics for Shawnee County were recently reported by the Kansas Department of Labor.

As of March 2021, Shawnee County had a 3.6% unemployment rate; this represents a significant decline in the local unemployment rate. For additional context, 3.6% is the among the lowest rate of unemployment reported for the month of March, between 1990 and 2021. Last month, February 2021 the official unemployment rate was 4.4% and 6.7% for January 2021.

In total, there are 3,277 people out of work in the county; this figure is more in line with that we usually saw prior to the recession. In contrast, the number of employed workers is at a record high for the month of March at 88,761 employed workers. There are cases, where the number of unemployed workers decrease, but not

because they were able to find employment, but instead because they left the work force entirely. This was not the case for the county; while the labor force is not a record high, we are seeing some significant expansion in the pool of available workers willing to get back to work.

Overall, we are seeing some positive news in the local labor market; employment is increasing at a decent pace, and it appears that we are heading toward a more natural level of unemployment.

The Kansas legislature returns to Topeka for the so-called Veto Session on May 3. Among their remaining jobs is passage of an education budget. The general state budget, with the education component held-out, passed at the end of the regular session. Importantly, the Governor exercised her line-item veto authority, rejecting several key provisions of the general budget bill. Key among them was a proviso which shifts ultimate authority over federal COVID relief dollars from the Governor to the legislature. Legislators are expected to try to override that veto as early as Monday.

They will also try to override the Governor's veto of a bill pertaining to the rights of transgender athletes. That bill passed the House and Senate, but not by a veto-proof margin. Proponents of the bill have been working to persuade enough legislators who may have voted against the bill to side with them in overriding the veto. Advocates in the travel and tourism industry worry the economic impact of a law restricting the rights of transgender athletes would be devastating as national sporting organizations and other groups have made clear they intend to only do business in states which embrace diversity in its many forms.

The GO Topeka team is working closely with the Kansas Department of Commerce on active opportunities in the aviation industry. Seven new leads in the industry are being developed, and GO Topeka is starting to convene more conversations on building up the specific industry assets we are light on like training. Topeka is on the shortlist for one aviation company and is waiting to hear about making the cut on another that will narrow their list in late May.

### STATE REP. BORJON VISITED THE MWBD COUNCIL

Each of the four main Partnership organizations are making good progress working through their respective nomination processes. They are all on track to present candidates to be elected directors for terms beginning on January 1, 2022. The deliberative process all Partnership boards take ensures they work from a broad pool of talented volunteer leaders and focus on ever-increasing diversity.

The GO Topeka Audit will wrap up in a matter of days. The final report will be presented to the GO Topeka board and JEDO in May. Visit Topeka's final audit report will not be too far behind that. The consolidated Partnership audit will be the last report finalized and will be delivered to the Finance Committee in June.

State Representative Jesse Borjon met with the Minority and Women Business Development Council to provide an update on legislative activity and to uncover specific needs of the community. Rep. Borjon has requested the Small Business Council and the Minority and Women Business Council to participate in a small business focus group to help him better align with the needs of the business community.
